WHAT IS HAPPENING TO MODERN ARCHITECTURE? (2 JUNE 2023)

MAIN GENERAL THEORETICAL FRAME.

The text of this call for papers considers the new environmental situation of the world by taking care of the dialogue between the artificial intelligence and the real social, and cultural experiences of the spaces produced after the COVID pandemic. As Professor Rainer E. Zimmermann insisted upon in his key speaker lecture in Barcelona in ARQUITECTONICS 2017 (1), the virtual world and the virtual users of this world have different abilities than the subjects with presential social interaction behaviors, and because of that, the dialogue between both dimensions of the human life is essential today. Also, for this same reason, Professor Josep Muntanola has accepted to participate in the coordination of the new master course in the UPC about THE ARTIFICIAL INTELLIGENCE FOR ARCHITECTS & DESIGNERS.

So, a New Sense of Place (2) is developing towards the liberation of the Heidegger obsession by architects in the last century, as Richard Sennet has very brilliantly analyzed in his last book (3), and this is analyzed in the volumes 32 and 33 of the ARQUITECTONICS SERIES (2) and (4). But this new place has not yet to be built, and we are inside an uneasy "INTERREGNE" between nature and culture subjected to ignore constraints.

Looking for answers in front of this coming situation, 75 years ago, in 1948, the MOMA Museum of New York held, with the coordination of Lewis Mumford, a singular Symposium with the title WHAT IS HAPPENING TO MODERN ARCHITECTURE? that has been analyzed in recent conferences in our network, and it will be one of the topics of this 21st conference in June 2023 (5).

If we consider the explosion of Design Schools all over, we should remind that both the Old Bauhaus and the School in Harvard founded by Gropius were **Schools of Design**, and for that reason we have now the nexus among informatics, digital bio-revolution, and design theories and architectural theories and practices that is inexorably developing. The link between education, profession, and social interaction is, then, the key point, and the answer to avoid a nightmare should be the "new sense of place". Perhaps a totally "new human sense" (but not an anti-human sense) is the answer of the puzzle, as the New Bauhaus is trying today to find.

Instead of fighting each other, artificial intelligence, the digitalization of the profession, and the social interaction between a healthy and peaceful cultural diversity of our society today should dialogue in order to find a new deep interdisciplinary and inter-artistic meaning on architectural and planning design practices and theories.

The knowledge of the mind, the social dialogue, and the power of the place, admired by Aristotle (6), should share this common knowledge. Of course, the three ask for, and point to, a new human freedom with democratic rules in and between the cities and cultures.



Consequently, the main dimensions of this new sense of place are:

First, history is no more *uni-linear* but poly-linear, each subject is a crossing place of histories (and stories) going to life (and not to death in a Heideggerian sense).

Second, this new place demands “authenticity”, ethical, scientific, and aesthetic, not “virtual” authenticity alone. The virtual subject and the living subject are different and they must be interrelated, but they cannot be confused.

Third, a new sense of home arises from these two premises, the new “home” (or “Bauhaus”) is a “Home” for human life, flesh and birth, and therefore the climatic control will be fundamental.

FACTS upon a DIALOGICAL equilibrium between virtual and real social life that the new sense of places should develop and build.

Fifth, a new human spatial memory is emerging from among algorithms and chronotopes, that is, between the machines and the human brains, and in this dialogue our brains produce the other way around the machines. AND THE ARTISTIC NEW DIGITAL INTER-ARTISTIC PERFORMANCES COULD BE GOOD FACTS TO ANALYZE.

These three dimensions of the **new sense of place** have been clearly defined by Luis Umbelino, following Paul Ricoeur’s ideas, in 2017 (6), and we have already defined the new knowledge that designers need in this new place, in two articles in the ISUF 2020 in Barcelona, and in the ISUF 2021 in Glasgow, and it has been described in an article in Moscow in 2022 (7) (8). We can conclude with the following argument by Sigfried Giedion in the reedition of his famous book, *Space Time and Architecture* in 1963, that was analyzed by Professor Josep Muntanola in the foreword of the Spanish edition of the last book by Giedion, *Architecture as a Phenomenon of Transition*, published in Barcelona in 1975 (9):

“Each generation of humans needs to look for an equilibrium between feeling and thinking, building a new architecture and planning able to articulate the interior and exterior dimensions of the human culture, supporting in this way their affinities “.

From the philosophical view by Paul Ricoeur, this implies a social dialogue between the *Arque* of Freud and the historical social Telos that he himself defined in his last book in 2005 (10). These two books, one by Giedion and another by Ricoeur, were posthumous books and they are almost forgotten.

Finally, a short synthesis of the situation today by Josep Muntanola has been recently published in Moscow (11)

MAY 31th: THE ARCHITECT EDUCATION

1) TEACHING ARCHITECTURE, URBAN PLANNING AND DESIGN TO CHILDREN

How to prepare children to live in a new place that is becoming a globalized world? How to combine the presidential and the virtual communication in the bio-revolution of the Covid 19? What are the best pedagogies for the involvement of architecture in education, besides mathematics, history, etc.? What kind of interdisciplinary skills are needed? What are the political implications of architecture and urban planning teaching in children's education? What are the spatial dimensions of the new experiential education, both in projects teams and personal activities? How to use the urban quality indicators developed by the UNICEF Program, the Child Friendly Cities? LAS CIUDADES AMIGAS DE LA INFANCIA? (*Sheridan Bartlett: Urban children: Discussion of UNICEF PROGRAMMING DIRECTIONS. New York, 2010*).

2) TEACHING ARCHITECTURE AND URBAN PLANNING IN THE UNIVERSITY

What are the best methods and theories for teaching architecture at universities? How to relate the virtual tele-education with the real social experience of physical spaces? Which interdisciplinary networks are more appropriate? How to analyze the best way to teach projects, whether with the same program and place for all students in a workshop, or individual freedom to create the program and place of project? How to achieve a balance between an individual obsession with innovation and a rigid homogeneous discipline for all participants in a workshop? How to relate the theories described above and teaching of architecture at the university? How to relate architecture schools with their historical and social environment in full transformation? (*Ashraf Salama: Spatial Design Education. Routledge 2015*.)

3) SMART CITIES AND BUILDINGS, THEIR DESIGN, PAST AND FUTURE.

Design teaching institutions have invaded our cities with hundreds of masters on design with the most diverse characteristics; we invite these institutions, their students, and professors to participate and discuss their theories and practices. How to use computer simulation in such a way that the scientific, aesthetic and ethical capabilities of the users increase.

What are the relations between design and art? How can these schools introduce the digital tools to produce a qualified design?

What are the relations between the city and designing public spaces, museums, etc.? How can the cities adapt to the new sense of place?

The new UPC master in Artificial Intelligence for Architects and Designers intends to answer these questions.

JUNE 1st: ENVIRONMENTAL DESIGN INNOVATIONS AND SOCIAL DIALOGICS.



4) SOCIAL PARTICIPATION IN PLANNING AND THE CONCEPT OF THE NEW SENSE OF PLACE CONSIDERED A DESIGN PRODUCT.

Experiences and theories about a social oriented planning process considering the cultural diversity of places and users, and the different factors and roles involved in this same process. The gentrification processes and the way to allow human welfare for all the different social groups and values, without social exclusions. (*Richard Sennett: Building and dwelling. Farrar, Straus and Giroux. New York 2018*). After the bio-revolution, the ethical responsibility of designers increases, and they cannot escape from it by using mathematical models.

5) TOOLS AND THEORIES FOR THE SOCIAL EVALUATION OF BUILDINGS AND CITIES, AND FOR THE SOCIAL PARTICIPATION IN PLANNING.

How can rehabilitation, renewal, and analysis of post occupation of places improve human life? How can interdisciplinary research help improve evaluation? What are the best theoretical interpretations of data? What is the role of architects in the social processes of participation of planning? What is the difference between traditional urban design and co-working and cooperative organization of architects, in relation to the social participation in architecture and in planning? What is the role of architects in the new sense of place? After the bio-revolution the ethnomethodological analyses are more important than ever. (See David Seamon's works).

6) ARCHITECTURAL DESIGN AND SOCIAL HISTORY: HERITAGE AND HISTORY OF URBAN FORMS

Life in cities cannot be fixed in a museistic way. However, to design to defeat the existing culture of cities is an artificial work that can only produce thematic parks, where the urban life is as dead as a videogame.

The dialogue and the convergence between tradition and modernity, and between innovative design and the history of culture are then needed, in order to build the new sense of place. To preserve our heritage in order to improve the human conditions of our cities is the key aspect at this point. Neither museums nor thematic parks, but livable cities that are in permanent, clever transformation thanks to the specific modernity of each place, and to social participation in planning. History has always dealt with epidemics, and they can help us now.

JUNE 2nd: WHAT HAPPENS WITH MODERN ARCHITECTURE?

7) THE EVOLUTION OF KNOWLEDGE IN DESIGN STUDIO: THE SPECIFIC MODERNITY

How can we generate the new sense of place from the building knowledge inside the interdisciplinary studios of architecture? How to uncover the difference in knowledge (embedded, extended or distributed) between single discipline and interdisciplinary design studios?

All theoretical views are accepted: phenomenological, systems theory, hermeneutic approaches, and other theoretical frameworks.

Analyze the design production in studios after the bio-revolution. The three transparencies in Architecture: Physical, mental and social. Generate the specific modernity in each historical situation.

8) DESIGNING AND BUILDING THE NEW SENSE OF PLACE

Sustainability and natural orders related to architecture and construction are welcomed. Dissertations about the interplay between technology and design processes are needed. Feedbacks between design and construction related to specific architects or generations of architects are needed.

9) USING DIGITAL TOOLS TO CREATE THE NEW SENSE OF PLACE WITH ARCHITECTURE AND WITH GENERAL DESIGN PERFORMANCES

Analyses about the feedback between experience and knowledge in the architectural and urban design processes are welcomed. PhD Dissertations about digital tools: space syntax, ELAN, ISOVISTS, BIOGENETIC ANALYSIS etc. as tools for a better design are needed. How to help control the pandemic with such a digital tool.



INTENSIVE PERMANENT COURSE THREE SESSIONS IN MARCH APRIL AND MAY 2023

ONLINE (IN PROCESS)

It will include the analysis and evaluation of the theoretical frames of masters and PhD Dissertations in process related to the network ARQUITECTONICS. And it will be a preparation for the conference too.

1. The fundamental correlations between design innovations and history of architectural culture: The physic- psycho-social epigenetic model by Gottlieb and Langer, and the topogenetic dimensions of human life by H. Pointcare, R. Zimmermann and P. Ricoeur in the new sense of place.
2. Reflections upon last architectures practical theories from an Aristotelian perspective: the three dimensional structure of architecture between design, construction, and the social use of places. Hillier, Alexander, and beyond with Mumford, Sennet and Bakhtin. The topogenetic model, the Umbalino explication of Ricoeur, and the Pierre Kaufmann vision of placeness.
3. The pathological perspective of architecture and planning in between three critical human phenomena: Illness, stress and war, and the basic role of criticism and education. The topogenetic model as social welfare. Artificial intelligence can be both a danger and a solution.
4. The practical wisdom of architects today in a global and digital world.
